ACKNOWLEDGEMENT OF 8% PREMIUM POLICY

Aladdin Bail Bonds has an 8% rate filed with the State Department of Insurance for Defendants who have retained private defense counsel, Defendants and/or Indemnitors who are enrolled in a labor union and Defendants and/or Indemnitors who are or were members of the Military and their immediate families. In order to qualify for the 8% rate, proper evidence must first be received by **Aladdin Bail Bonds**.

- **Retained Private Counsel:** The attorney must be **retained within 5 business days** of the bond execution date. A letter from the attorney retained or a copy of the contract between attorney and client must be received by **Aladdin Bail Bonds within thirty (30) days** of the bond execution date.
- **Union Members:** The co-signor or defendant must be actively enrolled in a union or receiving disability or retirement benefits from a union and must provide **Aladdin Bail Bonds** with proof **within thirty (30) days** of the bond execution date. A current Union card and a recent pay stub (union card itself can't stand alone), or a current payment of Union dues (not health care cards). If Union proof documents are questionable, a current letter from the Union stating member is in good standing will be required.
- **Active or Veteran Members of the Military and their Immediate Families:** Co-signors and defendants who are members of the Military must provide Aladdin Bail Bonds with proof of Military service **within thirty (30) days** of the bond execution date.
 - If the client is the immediate family of a member of the Military, a signed declaration from the member of the Military along with a copy of the members ID or other proof of service must be received **within thirty (30) days** of the filing of the bond. Immediate family is defined as a legal parent, spouse, child, adopted or foster child, sibling or half sibling.
- **Proof Must be Current or Recent:** Current proof shows an active military or union status via a future expiration date. Recent pay stubs, letters from unions, and other proofs with dates in the past must be dated not more than 30 days from the date of bail bond execution and must show that the customer is in good standing with the organization.

If proper evidence is received within the allotted time period defined above, **Aladdin Bail Bonds** Corporate Office will notify all clients by mail that the premium rate has been reduced to 8%. The account balance and promissory note will also be adjusted to reflect the new rate.
