Beginning November 1, 2011, the Santa Rosa Police Department will be charging for copies of *all* digital media to include audio recordings requested through the Property/Evidence Section. The CD or DVD will be provided and it is no longer necessary to provide a blank.

Sample of media requests are listed below:

- 9-1-1 Audio
- Police Radio Audio
- Video footage
- \*Photos requested on CD or DVD

**Please include a check made out to the Santa Rosa Police Department with all requests. The request will not be fulfilled until payment has been received.**

When your request is complete, you will be notified by telephone, and the items will be left at the front counter for pick up and your receipt will be stapled to the outside of the envelope.

\*The cost for Photo's to CD has been reduced from \$60 to \$22 which is consistent with the cost of other media.
