Breakdown of Fees & Penalty Assessments

- 1 State Penalty Assessment - \$10 per \$10 (or fraction thereof) of base fine.
- 2 County Penalty Assessment - \$7 per \$10 (or fraction thereof) of base fine.
- 3 Emergency Medical Services - \$2 per \$10 (or a fraction thereof) of base fine; Board of Supervisors approved on 08/21/07
- 4 State Surcharge - 20% of base fine.
- State Court Construction Penalty Assessment - \$5 per \$10 (or fraction thereof) of base fine; \$3 to State Court Facilities
- 5 Construction Fund and \$2 to the Immediate and Critical Needs Account.
- 6 Night Court assessment - \$1 per conviction
- 7 State DNA Identification Penalty Assessment - \$1 per \$10 (or fraction thereof) of base fine.
- 8 State DNA Identification Additional Penalty Assessment - \$4 per \$10 (or fraction thereof) of base fine.
- 9 Emergency Medical Air Transportation (EMAT) Penalty Assessment - \$4 per conviction of vehicle code
- 10 Court Operations Assessment \$40 per conviction
- 11 Criminal Conviction Assessment \$30 per conviction.
- 12 Restitution - \$120 Mandatory (inability to pay only a factor when increasing above \$120 but less than \$1,000)
Felony - \$220 Mandatory (inability to pay only a factor when increasing above \$220 but less than \$10,000)
